**Lake Wisconsin Alliance**

The Lake Wisconsin Alliance will host an educational meeting at the Village Hall on Tuesday, February 16, 2017 from 6-8 pm. The meeting is open to the public and the program is titled “The Merrimac Railroad Bridge: Past, Present, and Future.” Last August the Wisconsin Department of Transportation had approved the railroad’s project plans for a \$17 million repair and reconstruction project. **Alternate-Side Parking**

To aid the Village’s staff in winter snow removal from our streets, the Village’s alternate-side parking policy is now effect for the season. On odd-numbered days, residents must park on the odd-numbered side of the street. On even-numbered days, residents shall park on the even-numbered side of the street. **Snow Removal**

Clearing snow from sidewalks and ensuring access to mailboxes is the property owner’s responsibility pursuant to Village Ordinance 129-5. Sidewalks shall be cleared within 24 hours following the end of a snowfall event. If walks are not cleared within 48 hours, the Village will clear the walks and bill the homeowner for the service.

## Minutes of the Village Board Meeting of January 10, 2017

President Hahn called the Village Board meeting to order at 6:00 p.m. Board members present upon roll call included Nick Hahn, Jeff Rasmussen, George Naxera, Garry Bahe and Jim Malmberg. Also present was Village Administrator Ron Senger.

President Hahn examined the affidavit of posting and verified that advance public notice of the meeting conformed to statutory requirements.

### Public Input: None

Following review of the Village's outstanding bills and prepaid expenses, Rasmussen/Malmberg moved to approve payment of the bills as listed on the agenda. Upon roll call vote, **motion carried.**

Rasmussen/Bahe moved to approve the monthly financial reports including the balance sheet and budget comparison for December, 2016. **Motion carried.**

Hahn/Naxera moved to approve the draft Minutes of the December 13, 2016 Village Board meeting. **Motion carried.**

The Board considered a request from a Village resident who currently has an existing

Community Development Block Grant (CDBG) loan that was approved and administered through the Village in 2008. The resident is seeking to refinance her home at a lower interest rate and wishes to subordinate the CDBG loan to a new mortgage if she is approved. Following discussion by the Board, Rasmussen/Bahe moved to approve the loan subordination request incumbent upon the review and recommended approval by Kari Justmann, the appointed MSA CDBG Contract Administrator. **Motion carried.**

### Administrator's Report:

Ron distributed copies of the Minutes of the Sauk Prairie School Board Meeting of November 28, 2016 and the Village Inspection Report for January 6, 2016. The Inspection Report noted we recently found three flushing valves had split on the south side of the recirculating sand filter bed at the wastewater treatment plant from the severe cold spell we experienced during the first week of January. Ron noted we will be able to use a different section of the sand filter bed until we can replace the cracked, 3" PVC ball valves in the early spring. Ron also reminded the Board of the Village Caucus scheduled for Saturday, January 14th at 9:00 AM. (Terms for Village President Nick Hahn and Trustees Garry Bahe and Jeff Rasmussen will expire in April 2017.) The Village's annual financial audit field-work dates are set for February 6-9, 2017. A team from Wegner CPAs, LLP will complete the audit.

### Sewer Operations:

Nothing significant to report (NSTR).

### Water Operations:

Ron provided an update on the elevated water tank's depth sensor located in the control panel within the base of the water tower. In mid-December, the sensor had frozen and failed to function properly during a week of sub-zero, cold temperatures. Failure of the sensor to turn off the well house pump caused the pump to run continuously until the water tower tank was filled and overflowing. As a result, the sensor failure caused several thousand gallons of water to overflow before the problem was identified and rectified. Utility staff have subsequently placed an additional small space heater under the control panel (within the pedestal). The heater will be operating during all extremely cold periods to prevent the sensor from freezing again in the future.

### Planning & Zoning:

Nothing significant to report.

With no further matters brought before the Board, Rasmussen/Malmberg moved to adjourn the meeting. **Motion carried** and the meeting adjourned at 6:27 p.m.
